




Storefront Update

Signage Requirement Change

Based on feedback, new requirements based on building

size:



- If the width of the front of your building is 25' or less signage must be a minimum of 10 square feet.
- If the width of the front of your building is 26' 50' signage must be a minimum of 30 square feet.
- If the width of the front of your building is 51' or more signage must be a minimum of 40 square feet.

Getting the Health Care You Deserve

Your immigration information is safe, secure and confidential

It's important to have health coverage to keep you and your family healthy

Covered California is a place where you can compare and get health insurance plans, and get financial assistance to pay for your health coverage if you qualify. When you apply through Covered California, you can also determine if you are eligible for reduced premiums or Medi-Cal.

California residents who are U.S. citizens, U.S. nationals, or who are "lawfully present" can get health insurance with financial help through Covered California. Individuals with other immigration statuses may be eligible for health coverage through Medi-Cal, although the benefits may be limited.

If you are applying for health coverage for yourself or your family members, know that all of your information is safe and confidential.

Covered California, in partnership with the Mexican American Legal Defense and Educational Fund, the National Immigration Law Center, the National Association of Latino Elected and Appointed Officials Educational Fund, Asian Americans Advancing Justice - Los Angeles, the Coalition for Humane Immigrant Rights of Los Angeles and the California Immigrant Policy Center is encouraging everyone to apply for health coverage, without fear that their application will affect their immigration status or the status of their family members.

Tips for Entering Income

In order to successfully enter income into the online application, we provide the following tips:

- In the "First Date Paid" field, enter the estimated date that the consumer first received income this year from their specified income source, for example – their employer.
- For the "Last Date Paid" field, LEAVE THIS FIELD BLANK unless the consumer expects that they will no longer receive income from their specified income source within the next four months. If a consumer expects to lose their income source during this time period, then enter the estimated date the consumer will receive their last income from their specified source. If the consumer does not expect to lose their income within the next four months, again please leave this field blank.



CEC/PBE Account Creation Tips

- Copy and paste the delegation code (delegate key)
 you were provided
- Enter the exact Business Legal Name of your entity
- CEEs or PBEEs may find the Business Legal Name of their entity under their profile information

Password Complexity Rules

- You cannot use words found in a dictionary or names
- Your new password cannot be one that you have used within the last 24 passwords
- Your password must have at least 8 characters and have no more than 16 characters.
- Your password must start with a letter and include:
- At least 1 upper-case letter (A Z)
- At least 1 lower-case letter (a z)
- At least 1 number (0 9)
- At least 1 special character (#, \$, %, etc.)

Multi-State Plans

- For 2015, Anthem Blue Cross will offer the following Multi-State Plan (MSP) options:
 - Silver 70 EPO & PPO Multi-State Plan
 - Gold 80 EPO & PPO Multi-State Plan
- The Anthem Blue Cross EPO and/or PPO plans will be offered in all regions and zip codes.
- The Multi-State Plan version of Anthem Blue Cross EPO and PPO excludes coverage for non-excepted abortions as a covered benefit.
